New Business:

- A. Eagle Scout Kane McLaughlin was unable to attend today.
- B. Accepted the Administrative Citation Report given by Executive Director Patton. (Mendez/Ogden - 6/0) Rick Ferroni spoke regarding an administrative citation he received.

- C. Accepted the Recommended Proposed Budget for Fiscal Year 2014-2015 with one change. Animal Services removed the request for an Accounting Technician. (Ogden/Mendez– 6/0)
- D. Declared the Neuter Scooter as surplus and approved its sale. The proceeds from the sale of the Neuter Scooter will go toward the purchase of an Adoption Trailer. GSA Purchasing will assist. (Mendez/Ogden - 6/0)
- E. Approved a Request for Proposal to lease the vacant space at 3643 Cornucopia Way. (Ogden/Young – 6/0)

Director Report:

- a. Eagle Scouts have completed many projects for Animal Services. Recently, Kane McLaughlin poured cement mow strips in the outside kennel area. Animal Services can provide additional projects for the Eagle Scouts.
- b. An alternate to neuter surgery has been developed. Dr. Cadwell is certified to administer Zeuterin. Zeuterin representatives will come here and train the contract veterinarians and the RVTs.
- c. Horses – We are grateful to a number of agency's that assisted with forty horses from Patterson. Once the veterinarian deemed the horses healthy, the family came and took the horses. Out of six that were here, all but two have been adopted. The remaining two are available, healthy and have a starting bid of \$50
- d. This year's drought has yet to cause any horse abandonment issues.
- e. Animal Services was selected as the Reader's Choice, for animal adoption, in Ceres.
- f. Animal Services received a grant to spay or neuter privately owned dogs. We spayed or neutered 200 dogs, all Pit Bulls and Chihuahuas.
- g. Animal Services website will be updated soon. It is clean and user friendly.
- h. License Amnesty is coming in April and May.
- i. A meeting is scheduled in April, with the City of Riverbank, whose contract with Oakdale ends in June.
