- ii. Coming soon to Stanislaus County and surrounding areas Text "Strays to 555-888. This is a quick and easy way to receive guidance for finding lost pets. SASA will provide refrigerator magnets to clients, will list text "Strays" to 555-888 on our website and social media pages, will share with partner social media pages and public information officers, and, the program links to our lost/found animals.
- iii. SASA has been awarded a Volunteer Mentor Grant which will provide training and mentoring of our Volunteer Coordinator

- providing her information on retention and creating a Volunteer Operations Manual and Grievance Program.
- iv. We have Veterinarians on site daily to care for our shelter animals and the provide vaccines at our vaccination clinics. We are utilizing more extra help part time positions to assist with care and coverage, seven days a week.
- v. The trial period for staying open late on Wednesdays is about to come to an end. We will have a status update in January and may wish to extend this program to year-round.
- vi. SASA is looking at some new fees. Some fees will help cover expenses incurred when a client reclaims or adopts animals, like carriers or leashes. Clients may bring their own or purchase one. SASA is also considering the addition of flu shots to our menu of vaccinations.
- vii. The remainder of the year will be very busy, there are many items coming up, changes to our fee schedule, several contracts are due to expire in this quarter and budget will soon be due.
