- i. Annette introduced Kayla from DocuPet who provided an overview of processes to date. These processes included a soft launch, training with Modesto Animal Control, and training with SASA staff. A formal launch for public use is scheduled to take place the week of February 24, 2020. Yesterday 62 licenses were sold through DocuPet.
- ii. Annette introduced Adrienne Rios as the new Confidential Assistant for SASA.
- iii. Last week the Agency received a \$225,000 grant from PetCo Foundation. Half of the grant will be awarded in 3 to 4 weeks with the balance awarded in March of 2021.
- iv. Subaru was onsite yesterday filming a nationwide commercial and provided a \$2,500 donation.
- v. Annette recognized Kellie, a County employee, for her assistance with the grant for the Low Barrier Shelter.
- vi. Next month Annette will be speaking at the State Capital regarding the \$50,000,000 being awarded to California shelters.

- vii. The bidding process for the self-watering system was placed on hold due to the Assessment Team providing an alternative solution.
- viii. Annette discussed Heel for Meals utilizing food trucks to acquire donations for the Snip Bus to provide spay/neuter surgeries in varying communities. The first fund raising event will be held at CSA followed by Love Hughson and then the remaining cities.
