Director Report:

Deirdre McGrath has gone through the animal ordinances in their entirety. There are a number of concerns and she is getting input from Cities and the Executive Director. The Model Ordinances should be ready and sent to all JPA members by the first part of August for review prior to the September 20th JPA meeting.

Executive Director Patton has been looking at agencies that have good programs in place for Trap/Neuter/Release. Good programs have been found in San Jose and Florida. A grant was requested from Maddies Fund; however notification came in yesterday that they can not fund us this year. San Jose took a year to get their program together with environmental impacts and such. The idea is to determine, at intake, if a cat is adoptable, healthy and not adoptable or unhealthy. If a cat is adoptable, they will be housed as normal, spayed or neutered and placed up for adoption. If they are healthy but unadoptable, the cat will be spayed or neutered and released back to the area it came from. Unhealthy animals can not be released. We currently spay or neuter cats cared for by Kitty Care Taker colonies.

Vaccination clinics have been so successful that we will now be holding clinics every Wednesday morning (except holidays) and one Saturday morning per month.
