- a. Update on the Chihuahua/Pit Bull spay/neuter program, 455 of 600 coupons issued so far.
- b. Update on Technology programs. IPads are in use with Canvassers and in the Adoption Center. There are two more programs pending, account set up and telephone licensing.
- c. Update on PetCo, Turlock. SASA staff is there Saturdays and Sundays with dogs. Cats are there with assistance from volunteers. PetCo is very supportive of SASA and contributes canned food and fundraisers.
- d. Adoption contracts and other forms are now in English and Spanish.
- e. SASA participated in the Wellness Expo, taking dogs for attendees to see and pet. Most of these dogs have been adopted.
- f. Animal Adoptions are up 23% over last year.
- g. SASA and Modesto are discussing a proposed canvassing program for the City of Modesto.
- h. SASA was recently inspected by the Veterinary Medical Board with no major findings.
- i. A new 7 passenger van should be here very soon.
- j. SASA has a new logo.
- k. HR updates: With recent retirements, transfers etc. SASA is in need of two Animal Services Operations Supervisors, a Veterinarian and an Animal Care Specialist.
